Currently, 69.1% of the 30,475 housing units in the area are owner occupied; 24.4%, renter occupied; and 6.5% are vacant. Currently, in the U.S., 57.3% of the housing units in the area are owner occupied; 31.2% are renter occupied; and 11.5% are vacant. In 2010, there were 23,918 housing units in the area - 65.1% owner occupied, 25.6% renter occupied, and 9.3% vacant. The annual rate of change in housing units since 2010 is 11.37%. Median home value in the area is \$199,204, compared to a median home value of \$264,021 for the U.S. In five years, median value is projected to change by 3.68% annually to \$238,649.
