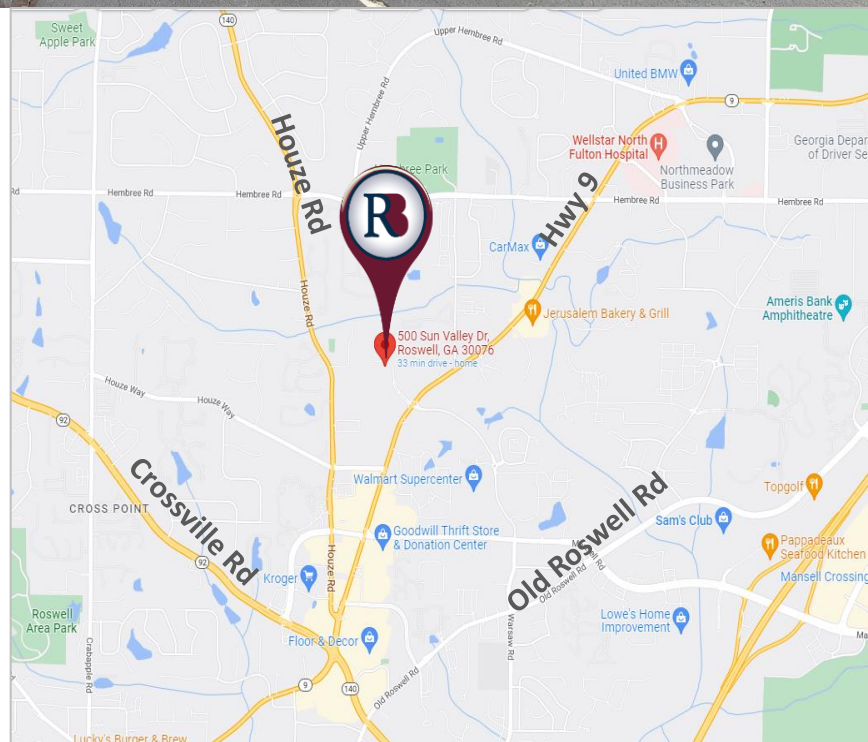

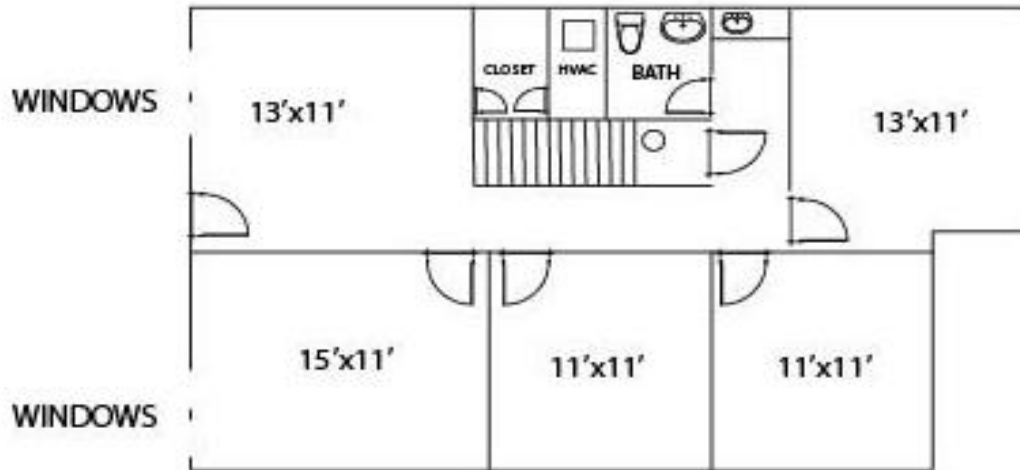

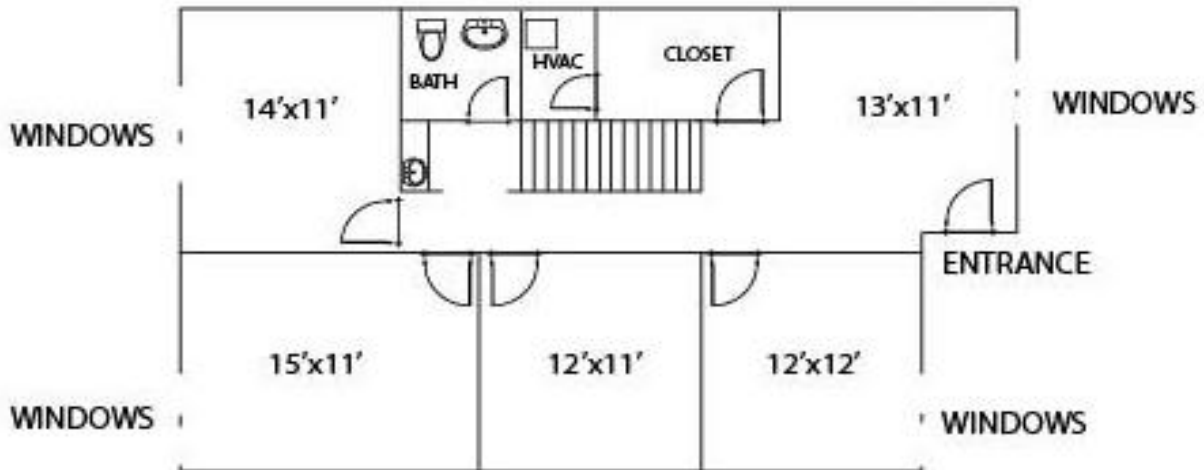
Floor Plan

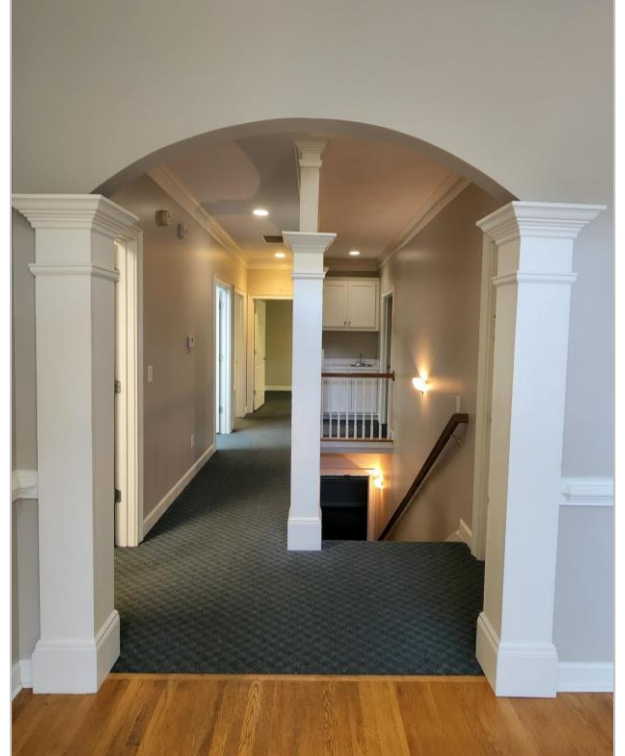
